ROCKET CITY BBQ COOK-OFF INFORMATION

KCBS Rules & Regulations apply. A copy of these will be mailed with the cook's packet and are also available online at www.kcbs.us.

1. Judging will start at 12:00 on Saturday afternoon.
2. Judging will be done on a category basis in the following order: Chicken 12:00, Ribs 12:30, Shoulder 1:00, Brisket 1:30, Dessert 2:00.
3. Desserts must be homemade and not purchased in a store. They do not have to be prepared on site. Desserts must be in a 9x9 box, provided by us.
4. Motorized vehicles are prohibited at all times during festival hours, unless otherwise authorized by the festival director.
5. Safety of this event is paramount! Any unsafe acts or safety issues identified by the Festival Committee will be immediately corrected. Failure to follow the direction of the Committee may cause removal from the Festival grounds.

Fire must be of wood, wood pellets or charcoal.
No Electric or Gas.

3. No beverage coolers will be brought in during festival hours.
